This instrument is made under subclause 485.231(1) of Schedule 2 to the *Migration Regulations 1994*.

4 Definitions

In this instrument:

Australian Qualifications Framework has the same meaning as in the *Higher Education Support Act 2003*.

Regulations means the Migration Regulations 1994.

5 Specified degree

For the purposes of subclause 485.231(1) of Schedule 2 to the Regulations, each degree is specified as follows, where that degree is awarded as a qualification at level 7 or higher of the Australian Qualifications Framework:

- (a) bachelor degree;
- (b) bachelor honours degree;

(d) graduate diploma;

- (e) masters degree (research);
- (f) masters degree (coursework);
- (g) masters degree (extended);
- (h) doctoral degree (research);
- (i) doctoral degree (professional);
- (j) higher doctoral degree.

6 Repeal

7 Application of amendments made by LIN 24/086

The amendments made by the *Migration Legislation Amendment (Graduate Visas No. 2) Instrument (LIN 24/086) 2024* apply in relation to an application for a visa made on or after the commencement of that instrument.

The amendment history in endnote 4 provides information about amendments at the provision (generally section or equivalent) level. It also includes information about any provision of the compiled law that has been repealed in accordance with a provision of the law.

Misdescribed amendments

A misdescribed amendment is an amendment that does not accurately describe how an amendment is to be made. If, despite the misdescription, the amendment can be given effect as intended, then the misdescribed amendment can be incorporated through an editorial change made under section 15V of the *Legislation Act 2003*.

If a misdescribed amendment cannot be given effect as intended, the amendment is not incorporated and "(md not incorp)" is added to the amendment history.
